Multi-Year Permit Agreement

The State allows qualifying Restricted Material Permits (RMPs) and Operator Identification Numbers (OINs) to be issued on a one (1) year, two (2) year, or three (3) year basis at the discretion of the County Agricultural Commissioner (3 CCR 6422). Starting in 2023, the Sacramento County Agricultural Commissioner will offer two (2) and three (3) year RMPs and OINs for production agricultural operations with qualifying perennial crops. Multi-year RMPs and OINs will also be offered for qualifying non-production agricultural sites. To qualify for a multi-year option, the following conditions shall apply:

- 1) Production agricultural multi-year RMPs and OINs may only be issued for the commodities listed on the attached page. No other commodities currently qualify for a multi-year issuance. For example, an RMP or OIN with commodities of walnuts and grapes would qualify. An RMP or OIN with commodities of walnuts and corn would not, as corn is not a qualifying commodity.
- 2) The RMP renewal date is set based on the renewal date of the associated certified applicator's license (PAC, QAL, QAC, etc.). In the case of an OIN, if there is no associated certified applicator, the renewal date will be set based on the attached Department of Pesticide Regulation (DPR) chart and name of the entity.
- 3) Permits for entities which are required to register with the Commissioner each calendar year (management firms, etc.) do not qualify for multi-year permits.

- 4) It is the responsibility of the RMP or OIN agent to notify the Commissioner of any changes. Failure to notify the Commissioner of changes will disqualify the agent from a future multi-year option. 5) All Pesticide Use Reports (PURs) must be submitted on time. Late PUR submission will disqualify RMP or OIN multi-year holders from a future multi-year option. 6) A Class A or Class B violation identified during the inspection of a permittee, or an unpaid fine or fee owed by the permittee, will disqualify the permit holder from future multi-year permits. I have read and I understand the conditions for issuance of the multi-year RMP/OIN. I would like to request the issuance of a multi-year RMP/OIN based on these conditions. I understand the multi-year option is a privilege that may be revoked by the Commissioner. FAC 14095: A private applicator certificate shall be issued for a period of three years except that the initial term of a private applicator certificate shall expire as follows: **a)** Certificates issued to private applicators on or after January 1, 1997, with surnames beginning with A to H, inclusive, shall expire on December 31 of each third year following December 31, 1997. **b)** Certificates issued to private applicators on or after January 1, 1998, with surnames beginning with I to Q, inclusive, shall expire on December 31 of each third year following December 31, 1998. **c)** Certificates issued to private applicators on or after January 1, 1999, with surnames beginning with R to Z, inclusive, shall expire on December 31 of each third year following December 31,1999.
